# MEMORANDAUM OF UNDERSTANDING (MOU)

#### Between:

**Kathmandu University**, an autonomous, not-for-profit public higher education institution (hereinafter referred to as "KU"). KU aspires to become a world class university devoted to bringing knowledge and technology to the service of Nepal. Its mission statement is "to provide quality education for leadership."

## And,

The United Nations Children's Fund (UNICEF), the United Nations Organization for children, (hereinafter referred to as "UNICEF"). UNICEF is the driving force that helps build a world where the rights of every child are realized. It is mandated to advocate for the protection of children's rights, to help meet their basic needs and to expand their opportunities to reach their full potential.

# 1. Background

UNICEF, in its effort to build support in favor of effective policies, laws and budget that promote the rights and well-being of children and women regardless of their socio-economic situation, gender, physical, mental abilities, culture or religion, highlights the important role of the academia in capacity building and national-ownership to achieve sustainable results.

Kathmandu University is an autonomous, not-for-profit, public institution dedicated to maintaining high standards of academic excellence. It is committed to develop leaders in professional areas through quality education. Its central campus is located in a mountainous landscape of Dhulikhel municipality about 30 kilometers east of Kathmandu having round-the-year pleasant climate and Panoramic Himalayan views.

In this context UNICEF recognizes the role of KU in the building and leveraging off the human resources infrastructure through innovative programs.

## 2. Objectives

UNICEF and KU (hereinafter referred to as "the Parties") enter into this Memorandum of Understanding (referred to as "MOU") pursuant to the desire to develop their collaboration in the areas of:

- 1) **Development of academic programs** in areas related to child and gender sensitive social policies and evaluation;
- 2) Promotion of a culture of innovation and entrepreneurship among young people
- 3) Collaboration in advancing evidence-based and equity focused research in public policies related to gender inequality, child rights, disability, and best practices in management
- 4) Creation of a platform for intellectuals and policymakers to exchange ideas and solutions for social challenges that face Nepal; and
- 5) **Dissemination of strategic information** on gender issues and well-being of children in Nepal

The parties will pursue other areas of collaboration to be agreed upon from time to time.

NOW THEREFORE the Parties agree as follows:

## 3. Term and Termination

- 3.1 This MOU shall commence upon its signature by the two Parties.
- 3.2 This MOU may be terminated by either Party giving one month's written notice



# 4. Roles and Responsibilities

4.1 This MOU will be supplemented by a separate Program Cooperation Agreements, which will specify roles and responsibilities of the Parties.

## 5. General Provisions

- 5.1 The Parties shall not assign their rights or obligations to any of their successors or assignees, unless by the express written agreement of the other party.
- 5.2 Neither Party has the authority to make decisions for the other, or to enter into obligations on behalf of the other.
- 5.3 This MOU shall constitute the whole and entire understanding of the Parties with respect to the matters specified herein and supersedes all previous verbal or written representation or communication with respect thereto.
- No amendments, variations or modifications in respect of this MOU shall be effective and binding unless in writing and signed by each of the Parties or their authorized agents in the presence of witnesses.
